Notice to all Prospective Bidders,

Please note the following amendments and clarifications to SCOPE OF SERVICES.

Section 1: ORIGINAL SCOPE OF SERVICES

Summary: This work request includes:

1. Full tree removals of dead trees noted under dead-remove and selection of scattered dead trees to be flush cut and left as habitat for wildlife
2. Tree maintenance consists of trimming, pruning, or removal of large dead stems, the latter of which can occur at the discretion and expert advice of the arborist following consultation and agreement with IERCD staff.
3. Chipping and distributing all biomass removed from tree removals and maintenance.
4. Chipping and distributing biomass stacks placed near removal areas by IERCD, prior to beginning of this scope of work.

Total recommended removals: 9 trees

Total recommended for maintenance: 11 trees

Section 2: AMENDED SCOPE OF SERVICES

Summary: This work request includes:

1. Full tree removals of dead trees noted under dead-remove and removal of scattered dead trees to be flush cut and left as habitat for wildlife
2. Completion of tree maintenance, defined as trimming, pruning, or removal of large dead stems, the latter of which can occur at the discretion and expert advice of the arborist following consultation and agreement with IERCD staff. Changes in scope once the contracted work begins will be compensated by IERCD based on review and approval of revised project budget submitted by the consultant.
3. Chipping and distributing all biomass under 5 inches in diameter resulting from tree removals and maintenance.
 - a. Any pecan wood over 5 inches in diameter to be left on site and made available for the public to pick up (see item 5.)
4. Chipping and distributing existing biomass stacks adjacent to removal areas.
5. Buck large pieces of pecan wood from tree removals into transportable sizes that can be used for firewood; IERCD will coordinate community pick-up following completion of scope of work.

Total anticipated removals: 10 trees

Total anticipated for maintenance: 6 trees

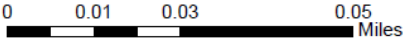
